Footnotes

RIVIERA (FR) was close up outside a rival early, bid three deep on the backstretch, dueled three wide on the second turn, took a short lead in midstretch and pulled clear under some urging. ROBYNHOOD angled in and saved ground in a good position, came out leaving the second turn, swung four wide into the stretch and finished well. MAJORIEN (GB) angled in unhurried early, moved up outside on the backstretch, dropped back outside a rival into the second turn, was floated five wide into the stretch but also closed well late for third. VOYAGERS QUEST angled in and saved ground off the pace to the stretch, split horses in midstretch and again in deep stretch with a late bid. ALVO CERTO (BRZ) sped to the early lead and set the pace along the inside, dueled inside leaving the backstretch and on the second turn, battled inside the winner in midstretch and weakened in the final furlong. WARD HUNT (IRE) was close up stalking the early pace a bit off the rail, bid between foes on the backstretch, dueled between horses on the second turn and into the stretch, then weakened in the drive. A claim of foul by the rider of MAJORIEN against ROBYNHOOD for alleged interference leaving the turn was not allowed by the stewards, who ruled the videotape failed to substantiate the claim.
