**Footnotes**

SMOKEY STOVER stalked the pace outside, bid three deep leaving the turn, gained the lead under urging in upper stretch and drove clear. PROUD TOWER TOO quickly sprinted clear, angled in and set the pace inside, dueled along the rail leaving the turn and into the stretch, could not match the winner in the final furlong but fought back for the place while drifting out late. BORDONARO stalked the pace off the rail, bid between horses leaving the turn and into the stretch, also drifted out late and bested the others. DEBONAIR JOE settled off the rail then angled in, went outside a rival on the turn, found the rail again into the stretch, came out a bit in the lane and was not a threat. NIGHTMARE AFFAIR chased between horses then off the rail, continued outside a rival on the turn then between foes nearing and into the stretch and did not rally. RED WARRIOR settled three deep early, angled in leaving the backstretch, saved ground on the turn, remained inside in the stretch and lacked the needed response. AREYOUTALKINTOME chased inside then off the rail, went three deep leaving the turn and into the stretch and weakened. SOUVENIR EVENING broke in and bobbled a bit, settled between foes then just off the rail, angled in on the turn and gave way.
