GOLDEN HORIZON went up inside to duel for the lead, fought back on the turn, inched away in the stretch and held gamely under urging. CIRCA'SGOLDENGEAR bumped at the start, pulled his way between horses then stalked just off the rail or outside a rival on the turn, came three deep into the stretch and finished well to just miss. TIZ ARGENT settled outside then off the rail, swung four wide into the stretch and gained the show late. SKY SEARCHER stalked outside then three deep, came five wide into the stretch, split horses in deep stretch and just missed the show. WARRENS PADDOCKGUY rank while pulling his way up between horses to stalk the pace, continued a bit off the rail on the turn, swung out into the stretch and lacked the needed late kick toward the inside. CAMICORY broke in and bumped a rival, stalked between horses then three deep, continued outside on the turn and four wide into the stretch and did not rally. LENDING FREEZE chased between horses then a bit off the rail, came out into the stretch and could not summon the necessary response. SONOFABLUR stumbled badly at the start, settled a bit off the rail then inside into and on the turn and was not a threat. DANCE MARINO angled in and dueled outside the winner, drifted in and bumped a foe in midstretch and weakened. MY BOY WALSH broke slowly and steadied when crowded, pulled his way up inside to stalk the pace, was bumped and steadied in tight nearing midstretch and again approaching the sixteenth pole and also weakened. SLEW CITY GOLD settled between foes then a bit off the rail and failed to menace. FULL EFFECT chased outside,

dropped back on the backstretch and approaching the turn and gave way.
