THEATER GOSSIP chased between horses early and off the rail down the hill, angled out wide into the stretch and rallied gamely under urging to get up at the wire. HOUSEKEEPER (IRE) stalked the pace outside down the hill, bid three deep leaving the hill and four wide into the stretch, gained the lead and inched clear and just failed to hold off the winner. PERT LAURA cut the right hand curve then angled in and saved ground off the pace down the hill, swung out into the stretch and finished well. SPEAKING OF TIME settled off the inside down the hill, came out some into the stretch and also put in a late bid. MISS CHIPS saved ground stalking the pace to the stretch, continued close up inside in midstretch, then weakened. BOX OFFICE GIRL was well placed stalking the pace three deep early then outside a rival down the hill and weakened in the stretch. NATIVE MIRACLE bobbed at the start, angled in and saved ground throughout, was blocked and steadied in midstretch and could not recover. WESTERN WOMAN sped to the early lead toward the inside, held a clear advantage down the hill, duelled between horses into the stretch and had little left in the final furlong.
