Footnotes

LASER POINT bumped at the start, angled in and dueled inside, inched away into the stretch and won clear under urging. SHELTER ISLAND settled inside, came off the rail leaving the backstretch, angled out on the second turn and a bit wide into the stretch and just got the place. FIERY TRIPPI prompted the pace outside a rival, drifted out through the stretch and held third between foes late. CAUSE squeezed back at the start, chased between horses then a bit off the rail, swung out into the stretch, angled in some in deep stretch and was outfinished for a minor award. PROFESSNL COURTESY saved ground stalking the pace, remained inside in the stretch and did not rally. CAMISADO (FR) a bit slow to begin, chased three deep or off the rail, came three wide into the stretch and lacked a further response. DEVIL CAT M D broke outward, stalked outside a rival, angled out into the stretch and weakened. ALABAMA BOY chased three deep then four wide on the backstretch and second turn and gave way.
