WOODEN PHONE had good early speed and dueled along the inside, kicked clear into the stretch and held sway under urging. TIZNOW off a trifle in the air but alertly, went up to press the pace three deep, was caught four wide into and on the second turn, came under some urging as the winner slipped away nearing the stretch, then could not catch that one while clearly second best. JIMMY Z unhurried toward the inside, came out in the stretch and gained the show late. TRIBUNAL bobbed in a slow start, pulled his way along off the rail early, bid between foes and dueled into and on the second turn, then weakened in the stretch but lost third late. NURDLINGER void of early speed outside a rival until nearing the stretch, angled in for the drive and did not rally. CAPO DI CAPO sprinted between horses early and dueled between rivals, continued three deep into and on the second turn, was roused while falling back leaving that bend and gave way.
