**Footnotes**

PRINCESS SUANCES rushed up from the inside to track pacesetter, whittled gap on that rival entering the lane, gained lead, kicked clear and safely held under right hand urging. A CLEVER TEN bumped leaving the gate, settled slightly off the rail, remained on same path into the stretch, shifted out nearing sixteenth marker, surged outside and was up for the place. BURNA DETTE settled inside, chased along the rail down the hill, angled out and finished gamely from between foes in deep stretch. BOEHLE was forwardly placed while bit off the rail, continued on same path and went willingly to the wire. UNUSUAL STRIKE broke inward and bumped rival, settled off the rail, chased three then four wide to the stretch and lacked needed late punch. I CAN HEAR settled mid-pack, chased outside rival down the hill, came four wide into the stretch and was outfinished. BOMBING TWO was slow into stride, lagged well back early, angled to the rail and lacked any late response. QUID NON flashed keen early foot and sprinted well clear, retained cushion while angling over, was collared in upper stretch and gave way readily inside. Rail on hill at 10 feet.
