Footnotes

BENCH THE JUDGE went up inside to duel for the lead, put a head in front leaving the backstretch, inched away a bit off the rail into the stretch, kicked clear under urging and held. HASTY TREND chased outside then alongside a rival leaving the turn, was in a bit tight between horses in upper stretch, continued toward the inside and held second. CLEAR TO CANADA settled outside or off the rail, came out leaving the turn and five wide into the stretch, bumped with a foe in upper stretch and just got the show. SUMMERS AT DELMAR chased a bit off the inside then angled in and saved ground tracking the pace, came out into the stretch and again in upper stretch and split foes late. BRADY BLUE EYES had speed outside then pressed the pace four wide to the stretch and weakened in the final furlong. HIGH SUCCESS bobbled slightly at the start, settled off the rail then outside a rival, swung out into the stretch and could not offer the necessary response. BRUNO'S WAGER had good early speed and duelled between horses until nearing the stretch and weakened. CHOP HOUSE GEORGE dueled three deep between horses, came out some in the stretch, bumped with a foe in upper stretch and also weakened. LASER POINT went between horses to chase the pace, angled to the inside on the turn and lacked a response in the final furlong. IT'S SUPERMAN allowed to settled off the pace inside, saved ground, came out into the stretch and did not rally.
