Footnotes

DEL MAR CAT had good early speed and dueled three deep, inched away and angled in some on the turn, drew clear and held under left handed urging. BRITE RED STATE taken wide early, began to advance outside a rival into the turn, continued inside, came out into the stretch and gained the place. HARD WOMAN settled off the rail then angled in some, came out into the stretch and bested the others. DIXIE COURAGE unhurried off the rail early, came out leaving the turn and four wide into the stretch and improved position. MALLEY GIRL dueled between horses on the backstretch, stalked the winner off the rail on the turn, came out into the stretch and weakened. BANDERA NEGRA went up inside to duel for the lead, dropped back on the turn and also weakened. I'M CONVINCED unhurried outside then off the rail, angled in some on the turn and gave way. DORI'S PROSPECT saved ground chasing the pace, continued inside in the stretch and was not a threat. MELODIOUS had speed between foes then stalked off the rail, dropped back leaving the turn and gave way.
