SUPER FREAKY chased inside, took the lead outside the pacesetter crossing the dirt, drew clear and held under urging. MACADAMIA chased a bit off the rail or inside, angled out into the stretch, came out under left handed pressured past midstretch to bump a foe and edged rivals for second. PAY WRIGHT chased off the rail then between horses, came out into the stretch, steadied in a bit tight off heels past midstretch and continued willingly late. SEASIDE AFFAIR stalked outside a rival, came out four wide into the stretch, was bumped and forced out past midstretch and also continued willingly. PRINCESS IRIS (IRE) chased outside, came four wide into the stretch, was floated out some in the drive and was outfinished. SETAFIRE off a bit slowly, settled just off the rail, came out into the stretch, steadied in tight past midstretch and lacked the needed rally. SEVEN STEPS (IRE) unhurried outside a rival or off the rail, swung out into the stretch, steadied in behind horses past midstretch, came out and could not offer the necessary response. SUMMER NEWS chased outside, came four wide into the stretch, was in tight past midstretch and lacked the needed rally. FOXY GAMES (GB) broke a bit slowly, settled inside chasing the pace and weakened in the stretch. PRENUPTIAL chased outside a rival then a bit off the rail to the stretch and did not rally. VOULEZ VOUS sped to the early lead, set the pace inside on a clear lead on the hill then broke down nearing the stretch. Following a stewards' inquiry, MACADAMIA was disqualified and placed sixth for interference in the stretch. Rail on hill at zero.
