PURPLE TOI stalked five wide on the backstretch, moved up four wide then three deep on the turn, came wide into the stretch, gained the lead, inched clear and held under urging. GREAT WHITE NORTH dueled outside a rival, inched away leaving the turn, continued toward the inside in the stretch, could not quite match the winner but held the place. CHAMP'S ROCKET sent between horses to stalk the pace, continued off the rail on the turn and three deep into the stretch and just missed second. SPRING FESTIVAL dueled inside, fell back into the stretch and weakened. DUBAI DOLLY off a bit slowly, went between horses on the backstretch, split rivals again on the turn, came out into the stretch and improved position. UNUSUAL BABE angled in on the backstretch and saved ground off the pace, moved up inside leaving the turn, came out into the stretch and also improved position. TONE'S PROSPECT settled off the rail, angled in some on the turn, came out in the stretch and was not a threat. IRISH WIT went up inside to stalk the pace, dropped back on the turn and weakened. MUCH sent between horses to track the leaders, continued outside on the turn and also weakened. DESTINEDTOBESTAR wide early, chased outside, went three deep on the turn and lacked a response in the stretch. HEIDI DO dropped back off the rail on the backstretch, continued outside a rival into and on the turn and failed to menace. R. H EXTERMINATOR off a bit awkwardly, was sent between foes early, was in tight on the

backstretch, angled in on the turn and had little left in the stretch.
