Footnotes

ROMANCE IS ZENON close up early and between rivals, waited for room early then midway on the turn, found path, split foes in upper stretch, drifted out some late and was up late. FOLLOWS NONE slightly off rail while chasing the pace, continued two wide into the bend, lacked room early on the turn, split foes nearing stretch, angled out and closed strongly outside to narrowly miss. TRUENO prompted the pace from the outside, continued three deep around the turn, gained brief lead in upper stretch but was outfinished. JOLYMPIO bumped leaving the start, stalked from off the rail, remained bit wide and finished strongly. WARREN'S JACK V. stalked from off the rail, bid from between rivals on the turn but weakened some in the drive. WHIZER close up from the inside, challenged from along the rail on the turn but also weakened some in the stretch. PRINCE MEYER settled well off the rail, remained bit wide and

was never a serious factor. THE ROYALS COURT lagged back from between foes, races three wide into and around the turn and never menaced. POLYGRAPH (IRE) angled in early, saved ground thereafter but never reached contention. LEONARDO C. S. unhurried while taken to the rail early, continued inside to the turn, later came off the fence but made no impact. LYON COUNTY KING settled outside, caught five then six wide into the stretch and was outrun. PARISIAN ART sped to the front and set the pace into the turn, dueled between, dropped back quickly around the bend, then was eased and later fell of apparent heart attack in the stretch. The stewards conducted an inquiry involving the stretch and did not make a change.
