QUE FACIL CORAZON angled over and gained early control nearing the initial turn, dueled inside rival to the stretch, then responded when roused and cleared foes. KISSING GIRL (ARG) forced to steady sharply approaching the first turn, reserved from along the rail, angled out on the final bend, forced four wide entering the stretch and bested the others from the far outside. LINDA EDER checked off heels nearing the first turn, was caught three deep early on that bend, moved up and contested the pace outside QUE FACIL CORAZON into the stretch before weakening slightly late. TOP SPINNER (NZ) forced in and then check momentarily off heels of QUE FACIL CORAZON nearing the first turn, then tracked the leading duo to second bend, raced three wide into the stretch and gave ground grudgingly late. SENORA POPPY in tight approaching the first turn, pulled her way into a prominent position, saved ground to the stretch, came out but lacked room nearing midstretch and never recovered. LOOKN MIGHTY FINE in tight and steadied sharply nearing the initial bend, reserved off the pace while saving ground and never recovered. Following a stewards inquiry and a claim of foul by the rider of KISSING GIRL against QUE FACIL CORAZON, the latter was disqualified and placed last for causing serious interference nearing the first turn.
