Footnotes

LASERBEAM JACKSON stalked from between foes early, moved up along the rail on the turn,came back out some, rallied strongly and collared leader late. BETTINGONTHEFLY reserved from along the rail, saved ground into the stretch, angled out in the drive, surged and was along for second. SAARFACE lagged back early, swung out around the turn, came six wide into the stretch, lugged out some in upper stretch and nearing the wire but still got up for share of show. WARREN'S CONCEPT set pressured pace while slightly off the rail, dueled outside foe around the turn, continued inside but was overtaken in late stages. BOSTON BAKED BEAN was off alertly but taken off the leaders, chased on two wide path, continued on same path and finished willingly. THRICE THE VICE was sent up inside, engaged pacesetter around the turn but weakened from along the rail. K K'S BRO (MEX) settled well off the rail, chased three wide then between horses and failed to menace. WHO U FOOLIN broke in and bumped rival, rushed up,stalked from between foes but weakened in the drive. ROCQUE'S GOLD bumped at the start, chased from off the rail, was three wide on the turn, came five wide into the stretch and failed to threaten. UNCLE WALLY chased on far outside early, angled over, trailed and was outrun throughout. CHIMU veered inward leaving the gate and unseated its rider.

The stewards conducted an inquiry involving the start but ruled that CHIMU cause his own problem.
