BRAVE ACT stalked outside a rival then off the rail on the first turn, bid alongside the runner-up to duel for the lead on the backstretch and second turn, took the lead into the stretch, came in on that rival past the eighth pole then pulled clear under some left handed urging. WONDERFUL UNION pulled and lugged out on the early lead, inched away nearing the first turn, dueled inside on the backstretch and second turn, fought back into the stretch, steadied in tight behind the winner past the eighth pole and could not match that one in the final sixteenth. HELLO FRANKIE chased between horses then outside a rival, angled in on the second turn and edged rivals for the show. SIR MACHO chased a bit off the rail then outside a rival, was between horses in the stretch and was edged for third. TENKILLER KID three deep on the first turn, chased outside a rival or off the rail, came three wide into and through the stretch and was outfinished for a minor award. REPS AND WARRANTS angled in on the first turn and saved ground chasing the pace, dropped back on the second turn, gave way and was eased late. BOSS OF ME pulled his way up along the inside and clipped heels leaving the first turn, had the rider lose the irons at that point and was eased into the second turn. Following a stewards' inquiry, BRAVE ACT was disqualified and placed second for interference in midstretch. The stewards conducted an inquiry into the incident leaving the first turn but made no change when they ruled BOSS OF ME was the cause of his own trouble.
