FUSAICHI PEGASUS was washy in the post parade, broke alertly but was content to settle outside and just off the pacesetter to the final bend, challenged and forged to the front entering the stretch and then held determinedly under moderate hand encouragement. THE DEPUTY (IRE) advanced steadily from the inside on the backstretch, then angled out outside the eventual winner around the second bend, loomed boldly four wide into the stretch and finished willingly under urging. ANEES unhurried from the inside before coming off the fence on the backstretch, raced a bit wide into the stretch and was along late for the show. COMMENDABLE quickly stepped to the front and set the fractions just off the rail to the final turn, relinquished control while continuing inside and weakened through the drive. GREY MEMO caught four wide into the first turn and three wide entering the backstretch, angled to the rail but failed to make any late impact. PROMONTORY GOLD settled from off the leaders while well off the rail into the backstretch, secured the fence on the second turn but lacked any stretch response. BUSTER B BIMBO washy in the post parade, bobbled slightly leaving the gate, was unhurried from the inside and never reached contention.
