**Footnotes**

WARREN'S SCOOTER stalked a bit off the rail on the backstretch and turn, split horses in the stretch and rallied inside under urging to prove best. SONIC COMIC between horses early, stalked three deep then outside leaving the turn, came four wide into the stretch and gained the place late. CRY ME NO RIVER sped between horses to the early lead, set the pace off the rail, held on well to deep stretch then lost the place late. SUPERSTAR JUSTIN five wide early, stalked four wide then outside on the turn and into the stretch and just missed the show. APPEALING DREAM chased off the rail then three deep, continued between horses on the turn and three wide into the stretch and had a mild bid. QUINTON'S FLEET stalked inside on the backstretch and turn and weakened in the stretch. FLIP THE PENNY close up stalking the pace between horses, came out into the stretch and also weakened. LUCKY THIRTEEN settled outside a rival then between horses, continued a bit off the rail leaving the turn and did not rally. FUTURE SEARCH broke a bit slowly, settled inside, came out into the stretch and was outrun.
