MISSDEALORNODEAL sped to the early lead, dueled outside a rival down the hill, put away her pace rival crossing the dirt, drew clear in midstretch on the inside, and was able to hold all foes safe to the wire under left handed urging. LINDA LOU chased the pace off the rail coming down the hill, bumped with a rival crossing the dirt, came into the lane three wide, rallied between horses in the final furlong and just missed at the wire. TALKTOOMUCH broke a bit slowly, settled in the early going, chased outside a rival coming down the hill, entered the stretch four wide, rallied in the final furlong and gained the show in the final yards. LEA THE PUNISHER moved up into the right hand bend to press the pace, dueled on the inside coming down the hill, could not keep pace with the winner while crossing the dirt, weakened in the final furlong and lost the show late. MIZZEN DONALD stalked in a good position coming down the hill, bumped with the runner-up crossing the dirt, came in and bumped a rival at the furlong marker and weakened in the final furlong. ARRIVEDERCI CARO chased on the inside down the hill, remained inside while crossing the dirt, was bumped and steadied in midstretch while in tight on the inside and fell back. Rail on hill at 14 feet.
