Footnotes

FUTURAL stalked the early pace outside a rival, bid outside LESTERS BOY and dueled on the backstretch and second turn, put a head in front leaving that bend, inched away in the stretch and held on gamely along the inside under left handed urging. IRISHEYESAREFLYING close up stalking the pace along the rail, waited off heels briefly leaving the second turn, came out into the stretch, split horses in upper stretch, could not catch the winner but was clearly best of the rest. TRIBUNAL saved ground chasing the leaders, went between rivals on the second turn and three deep into the stretch and picked up the show. LESTERS BOY hopped at the start, sped to the early lead and angled in, set a pressured pace along the inside but weakened in the stretch. COYOTE LAKES well placed tracking the leaders outside a rival, went three deep on the second turn, drifted wider into the stretch and also weakened.
