Footnotes

ST. EULALIA unhurried early, moved up inside on the turn, swung out into the stretch and rallied under urging to get up late. SHESCHAMPAGNEROSES crossed inward sharply and stalked the pace outside CASINO STAR, bid three deep on the turn, took a short lead but could not hold off the winner. TEE FOR THREE, three deep on the backstretch, split rivals on the turn and picked up the show. CASINO STAR, sent inside early, took a short lead between horses on the turn, battled inside in midstretch but weakened some. IVYCOVEREDWALLS, took up sharply between horses on the backstretch, moved up inside on the turn, swung out and improved position. CLEAR SKIES, close up outside early, went five wide into the turn and four wide on the bend and weakened. KITTY'S CHOICE, steadied and was forced in early, found the rail on the turn and lacked the needed rally. HUSHED raced wide throughout and failed to menace. TAPIOCA, angled in and sped to the early lead, dueled inside on the turn and weakened in the stretch. MIDNIGHT FANCY was taken well off the rail on the backstretch and came wide into the stretch. KI ORDER, settled off the rail, dropped back on the turn and gave way. COOL PRINCESS, also settled well off the rail, angled in for the turn and was outrun. Following a claim of foul by the rider of IVYCOVEREDWALLS,

SHESCHAMPAGNEROSES was disqualified and placed seventh for interference on the backstretch.
