BAHAMA MAMA (IRE) sped to the early lead, set the pace inside, drifted out crossing the main track, battled outside a rival through the drive and inched away under urging late. LIGHTMYFIREBABY stalked between horses then outside a rival, was forced out into the stretch but continued willingly between foes late. WAKE UP MAGGIE (IRE) a bit slow to begin, settled off the rail then moved up four wide on the hill and five wide into the stretch and finished well outside. SUPER FREAKY pulled her way along to stalk outside or off the rail, was forced four wide into the stretch, continued outside then was edged for a minor award between horses late. RED DIADEM (GB) stalked a bit off the rail then inside, bid along the rail in the stretch and was outfinished. MACADAMIA pulled early, chased inside, was in a bit tight on the hill and finished willingly inside in the stretch. STORMIN MON was in a good position stalking the pace inside, came out a bit into the stretch and lacked the needed rally. SHERMEEN (IRE) pulled her way along outside then steadied in tight between horses on the hill, came out five wide into the stretch and could not summon the necessary response. GOOD MOOD (IRE) chased between rivals down the hill, came three deep into the stretch and could not offer the needed late kick. JUSTICE IS BRIEF broke through the gate before the start, settled off the rail then steadied in tight between horses after the right hand curve, angled in leaving the hill and did not rally. INGRID THE GAMBLER pulled her way between horses to stalk the pace, continued outside then between foes again leaving the hill, was forced out a bit into the stretch and weakened. Following a stewards' inquiry, BAHAMA MAMA was disqualified and placed fourth for interference crossing the main track. Rail on hill at zero.
