### Footnotes

ROCHELLE'S JIMMY had good early speed and dueled a bit off the rail, angled in and inched away on the turn and held on gamely under urging. WHITE LACE JIMMY settled inside, came out on the turn and four wide into the stretch and finished willingly. TAVERN stalked outside a rival or off the rail, came out four wide into the stretch and also finished with interest. FLASH DANCER dueled between horses then stalked a bit off the rail on the turn, was between foes past midstretch and weakened some. UNCLE JEEP angled in and dueled outside foes, stalked alongside a rival on the turn and also weakened. LET'SPICKUPTHEPACE broke inward and slowly, went up inside to stalk the pace, continued along the rail in the stretch and lacked the needed response. TURBO CALL chased outside a rival or a bit off the rail, waited a bit behind horses in midstretch and could not offer the necessary late kick. MR. HOLMES broke a bit slowly, settled off the rail, came out into the stretch and was outrun.
