APPEALING (IRE) pulled three deep early then chased off the rail or outside a rival, came four wide into the stretch, rallied between horses under urging to gain the lead in deep stretch and gamely prevailed. CHIMI DEE broke a bit slowly, settled outside a rival, came out leaving the hill and four wide into the stretch and finished well. CANDY AND THUNDER also a bit slow to begin, settled just off the rail then inside, came out into the stretch, waited off heels in midstretch, came out again and just got the show outside foes. POSSIBLE (GB) chased off the inside then outside a rival, split horses leaving the hill, came three deep into the stretch and was outfinished. SWEET ASSAY angled in and dueled outside a rival, took a short lead into the stretch, battled between foes in deep stretch and was overtaken. SASSY SUANCES went up inside to duel for the lead, fought back on the hill and in the stretch and weakened some late. TWELVE FOLDS close up stalking the pace off the rail then between horses in midstretch and could not offer the necessary late kick. JET BLUE GIRL angled in after the right hand curve and stalked inside to the stretch, remained on the fence and lacked the needed response. CHESTNUT MOON hesitated then broke in the air and into the side of the gate and slowly, settled off the inside, angled in some leaving the hill and was not a threat. Rail on hill at zero.
