CEEBAND broke awkwardly and a bit slowly, angled in, moved up inside early on the turn, came out three deep leaving the bend and gained the place late. NAUGHTY NACHO stalked the winner a bit off the rail, was no match in the stretch and just lost the place. BADGETS RULER, chased the winner outside, continued outside a rival on the turn and weakened. MR. SEATTLE, steadied in a bit of a slow start, angled in and saved ground to no avail. PATRICK'S SLEW settled off the rail, angled in on the turn and gave way.
