CAYANNA had speed three deep between foes then stalked outside a rival, came three wide into the stretch, bid outside foes in midstretch, gained the lead nearing the sixteenth marker and gamely prevailed under urging. EVASIVE CHARMER stalked a bit off the rail then inside, came out in upper stretch, bid between foes in the drive, fought back inside the winner and continued willingly to the wire. SUNBURN chased outside, drifted five wide into the stretch and just got the show. BIG TSIMMIS between foes early, settled inside chasing the pace, continued along the rail in the drive and was outfinished for third. BODIE GIRL dueled inside, inched away leaving the hill, fought back in midstretch and weakened late. WARREN'S FLYER dropped back outside then angled in off the rail, swung out into the stretch and improved position. PHI BETA HEAT settled off the rail then angled in leaving the hill and lacked the needed rally. RUSSIAN BAYOU chased between horses then outside a rival, split foes leaving the hill and could not offer the necessary response. TIZ A BUD GIRL settled outside chasing the pace, came four wide into the stretch and also lacked the needed rally. SUGAR SPIKE dueled between horses then

outside a rival, stalked just off the fence leaving the hill and weakened. THISONEFORYOU dropped back between foes then a bit off the rail, came out into the stretch, was eased in the final sixteenth then unsaddled past the wire and vanned off. Rail on hill at 14 feet.
