Footnotes

SEVEN BRIDGES stalked a bit off the rail, awaited room leaving the second turn, went around a rival in midstretch, bid inside to gain the lead in deep stretch and proved best under urging. CANDY'S JEWEL stalked three deep then off the rail, bid three wide on the second turn to gain the lead, battled between foes leaving that turn, inched away in the stretch, fought back outside the winner in deep stretch but could not quite match that one late. DYLAN DONNELLY stalked outside, moved up four wide then bid three deep leaving the second turn and into the stretch and held third. CONFEDERATE CAT chased three deep then off the rail leaving the backstretch, continued outside on the second turn and five wide into the stretch and lacked the needed rally. JOLLY JOSEPH four wide into the first turn, chased off the rail, angled in leaving the backstretch, came out in upper stretch and did not rally. AWESOME ADDRESS stalked off the rail, came out four wide into the stretch and lacked a further response. TIMBERLITE had good early speed and dueled inside, fought back on the second turn and weakened in the stretch. TIZ SNAZZY chased between horses then off the rail, swung out four wide into the stretch and was not a threat. MONSTER HIT pulled his way along outside then dueled alongside a rival, battled between horses on the second turn, dropped back leaving that turn and had little left for the stretch. BIO PRO stumbled badly at the start, settled outside a rival then off the rail, gave way and was eased in the stretch. MISTER NOW tugged his way along toward the inside, saved ground off the pace, dropped back and drifted out some while being pulled up into

the second turn and was vanned off. FIT TO RULE sent inside early, dropped back a bit off the rail on the backstretch and also was pulled up and vanned off.
