Footnotes

DELL PLACE unhurried outside a rival early, continued outside on the second turn, swung five wide into the stretch and closed steadily under left handed urging to get up. TRIAL BY JURY angled in and stalked the pace inside, went between horses on the second turn, bid inside rivals and took a short lead past the eighth pole and held on well but was caught late. SEA TO SEE three deep on the first turn, chased outside a foe, moved up outside on the second turn and four wide into the stretch and finished well. TRADITION ROCKS stalked outside a rival, went three deep on the second turn and four wide into the stretch, gained a short lead nearing midstretch and continued willingly but was outfinished. REEF DIVER (GB) angled in and chased outside a rival, was between horses on the second turn, came out into the stretch and had a mild bid. LONG GONE CON three deep into the first turn, stalked outside a rival, bid outside the leader on the backstretch, gained the advantage leaving the second turn, battled between horses in midstretch, then weakened. STRATUS (FR) saved ground chasing the pace, came out for room and went around a foe leaving the second turn and lacked the needed response. DOC HOLIDAY (IRE) prompted the early pace inside then stalked along the rail, dropped back into the stretch and weakened. QUE BORGES (ARG) pulled his way to the front outside a rival, angled in on the backstretch, dueled inside and weakened in the stretch. WIXOE EXPRESS (IRE) off a bit slowly, settled off the rail, came out into the stretch and was outrun.
