Footnotes

JOE CARL was unhurried down the backstretch and around the second turn while off the rail, angled towards the inside leaving the furlong marker, took the lead at the sixteenth pole and held to the wire. TIME FOR ATONEMENT sped to the early lead between horses, maintained the advantage down the backstretch, was challenged for command on the second turn, drifted out some through the lane, went gamely to the wire and settled for the place. FOG ALERT settled off the rail down the backstretch and around the second turn, remained in the middle of the track for the stretch drive and rallied in the late going to gain the show. GUIDING HAND stalked the pace on the outside down the backstretch, bid for command on the second turn, drifted out some though the lane and was edged for the show in the final strides. FREE BEER angled off the rail around the first turn, bid for the lead three deep entering the backstretch then outside a foe approaching the second turn, weakened on that bend and fell back through the stretch.
