BUCKLAND MANOR angled in and stalked the pace inside, came out leaving the second turn, bid three deep into the stretch, gained the advantage past the eighth pole under some left handed urging and pulled clear. EXPRESSO BAY stalked outside the winner early, bid alongside the pacesetter on the backstretch, dueled for command, took a short lead into the stretch, battled inside the winner in midstretch as the rider lost the whip, then could not match that one but held second. SEQUOIAN off a bit slowly, saved ground off the pace, moved up inside on the second turn and into the stretch, came out past midstretch and finished well. VACAMONTE (GB) saved ground chasing the pace, came out into the stretch and lacked the needed late kick. LORD JIM (ARG) pulled a bit inside then chased a bit off the rail, went between horses into and on the second turn, came out in the stretch and could not summon the necessary response. BOURBON COUNTY chased three deep into and on the first turn, continued off the rail, went between horses into the second turn and did not rally. SHADOW OF ILLINOIS sped to the early lead, angled in on the first turn, dueled inside on the backstretch and second turn and into the stretch but weakened in the final furlong. LENNYFROMALIBU chased between horses then outside a rival on the second turn, came three deep into the stretch and weakened. INVESTOR'S DREAM (BRZ) four wide into and on the first turn, chased outside then off the rail and failed to menace. DISTINCTION well placed

chasing the pace three deep, dropped back on the second turn and weakened.
