STORM MATE chased outside rivals then alongside a foe leaving the hill, came three deep into the stretch and rallied under urging to get up late. TEN DOWNING STREET (IRE) dueled off the rail then angled in on the hill and battled inside, inched away in midstretch, could not quite match the winner late and just held second. CODE AMOUR prompted the pace outside the runner-up, continued off the rail in midstretch and continued willingly between foes late. GIMME S'MOR pulled his way between horses to chase the pace, continued inside on the hill, came out some in the stretch and was outfinished. VALID MECKE also pulled between foes early, chased a bit off the rail on the hill, angled inward in deep stretch and finished with some interest. BUCK TUDDY BUCK was in a good position stalking the pace inside, continued between horses in midstretch and weakened. LIVER chased outside, came four wide into the stretch and could not summon the necessary late response. RUSH RUSH broke a bit slowly, chased between foes then a bit off the rail, swung five wide into the stretch and lacked the needed rally. MIRACLE HILL pulled between foes and steadied early, chased three deep down the hill and five wide into the stretch and could not offer the necessary late response. UNREQUITED saved ground off the pace and did not rally. VEILED SPEED settled outside, went three deep on the hill, came out into the stretch and was not a threat. ABACONIAN (IRE) bobbled at the start, raced between foes then dropped back

off the rail and was outrun. Rail on hill at zero.
