CALIFORNIA NECTAR stalked a bit off the rail, bid alongside a rival on the turn, took the lead a quarter mile out, kicked clear under urging and held. WARREN'S FLYER chased outside a rival or off the inside, came out some in the stretch and finished with interest to be second best. BATHING BEAUTY allowed to settle a bit off the rail on the backstretch and turn, angled inward in upper stretch, came out in deep stretch and just got the show. TEDDY'S PROMISE a bit slow to begin, had good early speed then pulled a bit while setting the pace inside on a clear advantage, offered little resistance when challenged leaving the turn and weakened but just lost third. GOING FOR A SPIN chased outside a rival or off the rail, came out on the turn and three deep into the stretch and put in a late bid at a minor award. SCREAMING REGAL broke a bit slowly, settled off the rail, went outside a rival on the turn, came three wide into the stretch and did not rally. NOISE OF THE CROWD stalked the pace inside, dropped back on the turn and gave way then was eased late.
