Footnotes

QUICKFIRE (GB) off a bit slowly, settled off the rail, came out four wide into the stretch and rallied under steady handling to gain the lead past midstretch and pulled clear. GRAND MISS stalked outside, came four wide into the stretch, gained a short lead while drifting in some in midstretch, could not match the winner but held second. CHAMPAGNE DREAM stalked inside, came out crossing the dirt, was boxed off heels and steadied in midstretch, split rivals and gained the show. CLASSICAL LADY dueled between horses, steadied leaving the hill, angled to the inside in the stretch and went willingly to the wire. PALACE ROSE chased outside then off the rail, came four wide into the stretch, steadied in midstretch and could not summon the necessary late kick. PINDARIC sped to the early lead, dueled four across then three deep down the hill, battled between foes in midstretch and weakened. SPIRIT OF NATURE broke slowly and inward, settled off the rail, swung five wide into the stretch and found her best stride late. ON LONDON TIME dropped back early, settled inside, came out into the stretch and was not a threat. SALTY SALLY went up inside to duel for the lead, fought back on the hill but weakened in the stretch. CALL A JUDGE chased between horses then inside and also weakened in the lane. REY LAKE pulled her way between horses to duel for the lead, dropped back on the hill and gave way. A claim of foul by the rider of CHAMPAGNE DREAM against GRAND MISS for alleged interference in midstretch was not allowed by the stewards, who ruled both runners contributed to the incident. Rail on hill at zero.
