MOM'S APPEAL was outrun early, rallied on the rail approaching the stretch, drew clear inside the eighth pole then dug in gamely and held on, driving. SEMINOLE GAL was outrun early, came wide into the stretch and finished gamely outside. BREADKNIFE stumbled at the start, raced close up early, raced three wide into the stretch and lacked a rally. SACKVILLE PARADE raced three wide and tired in the stretch. RADIANCE (VEN) quickly showed in front, set the pace, drew clear nearing the stretch and gave way in the final furlong. MAGGIE'S TURN tired after showing brief speed.
