ZONE JUDGE contested the pace from the outside, responded when roused and drew clear under a drive. AMJAAD broke awkwardly, was pinched back after the start, put in a three wide run on the turn and raced greenly through the stretch. RANSOM'S FIRE broke awkwardly, bobbed after the start, was outrun early, came wide for the drive and finished well outside. MONGOOSE chased the pace and raced greenly while tiring in the stretch. TAILFROMTHECRYPT was hustled outside, raced four wide and tired in the stretch. LORD LIGHTNING raced greenly along the inside and tired. FAX AND GO was hustled along outside but had no response. FAST CITY raced inside and tired. CARMICHAEL contested the pace along the inside and tired after a half mile. LOUISIANA LONGLEAF raced greenly while wide and tired.
