### Footnotes

MY GOLDEN OPINION veered out at the start, moved up on the outside, raced three wide on the turn, was asked outside the quarter-pole, came under stronger urging in upper stretch, was put to a right-handed whip near the furlong marker, closed well on the outside to gain the lead and held off the fast closing runner-up under continued right hand urging. SYSTEM RESTORE was eased back to avoid the scrimmaging in front of him outside the half-mile pole, settled towards the rear, went three then four wide on the turn, was asked outside the quarter-pole, came five wide into the stretch, was put to a left-handed whip in the vicinity of the three-sixteenths pole, rallied into the final furlong and finished fast but was too late. HERO FIGURE broke out at the start, took the lead then quickly crossed in front of the field, was taken in hand once doing so, set the pace through moderate fractions, vied inside on the turn, was asked at the top of the stretch, held a clear lead into the final furlong but was overtaken while clear for the show. SCORCH THE TORCH was reserved while in tight quarters while between rivals, went three then four wide on the turn, was put to a drive in upper stretch and lacked the needed

response. IN JUST WE TRUST bumped with a rival after the start, raced up close to the pace while in hand, bumped with MITIGATION near the seven-sixteenths pole, dropped back after doing so, raced inside on the turn, lugged out under right hand encouragement in the stretch, was taken in hand near the sixteenth-pole and just missed the last spot in the superfecta. SAINTS ALIVE showed early speed then chased the leader, was urged along while off the rail on the turn, came under a left-handed whip in upper stretch and weakened. MITIGATION dragged his way up between rivals while hard to rate, bumped with IN JUST WE TRUST near the seven-sixteenths pole, dropped back after doing so, went two then three wide on the turn and came up empty. RIVER CITY REBEL bumped with rivals after the start, settled at the back of the field, shifted three wide midway through the turn, continued three wide into the stretch and failed to threaten. MR. HADIF bumped with RIVER CITY REBEL after the start, dropped back while under a hold, lost position near the half-mile pole, dropped to the inside on the turn and faltered.
