### Footnotes

SAGINAW away in good order, was kept at a considerable distance from off the rail at all times, bided his time from the top of the turn until its midway point, advanced steadily towards the leader thereafter, two to three wide, achieved a good striking position as the field headed into the stretch, quickly latched on fully to the pacesetter, had just struck the front when he commenced to drift outward, steadily added to the winning margin while continuing to make his way towards the middle of the track during the final furlong. MINE OVER MATTER was guided over to the rail shortly after departing the chute, was lightly handed urged by the pilot but remained well off the others for the opening half, began to fan outward arriving at the quarter pole, eventually settling into the four path by the top of the lane, went onward for a couple of jumps before getting called upon, rallied in unison with SARATOGA SNACKS, got the best of that opponent right near the finish line to procure the place. SARATOGA SNACKS assumed a forward position soon after the start, ranged up from the rail to draw abreast of B SHANNY nearing the half mile pole, had the aforementioned rival drift inward slightly, wound up being tightly pocketed, bumped with the leader then was forced to check, losing both valuable momentum and ground, got going again in short order, cut the corner into the lane and was asked for run, was rapidly approaching the fighting front runners when steadied once more before altering course sharply to be placed outside them, all this occurring in the vicinity of the three-sixteenths marker, forged on ahead, but with little success cutting into the top one's lead, altered course again in the late stages, reacting to SAGINAW's errant ways, then lost second in the final jump. B SHANNY grabbed a narrow advantage soon after the start, showed the way primarily two wide making his way down the backstretch, facing some pressure both from the rail and to his outside, had the inside pressure increase coming to the end of backstretch, came in slightly spinning into the turn, but enough to lead up to making contact with SARATOGA SNACKS, continued on the front end, still placed at a slight distance from off the rail, entered the stretch with the top one poised to strike, lost the fight to that rival racing through the furlong grounds and steadily backed away.
