DOOMSDAY DEFENSE speed inside, chased winner into stretch, weakened late. TWENTY THREE RED greenly, wide turn, no threat with a mild late rally. ROYAL RUBY hustled outside, wide move turn, nothing left for drive. BRIAN A greenly between rivals, checked backstretch, carried wide turn. GROUND TRUTH rail trip, no response. JUDGE MURPHY rail trip, tired. CLASSIC RUNNER very greenly, ducked out turn. STEPHANIES DOUBLE outrun. VERSUS greenly, tired. HOWAREYA brief speed, stopped.
