FOR FILLIES THREE YEARS OLD WHICH ARE ELIGIBLE FOR THE NEW YORK STALLION STAKES. By subscription of \$100 due on or before December 1, 2002, with the following eligibility payments: \$100 due on or before November 1, 2003; \$250 due on or before March 1, 2004; \$350 due on or before June 1, 2004. \$1,000 to pass the entry box, \$1,500 to start. All monies to be divided 60% to the owner of the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth and 2% divided equally among remaining finishers. 5% of purses won to be awarded to the stallion nominator. 122 lbs. Non-winners of a sweepstake at a mile or over in 2005 or three races allowed 2 lbs.; a sweepstake or two races, 4 lbs.; a race at a mile or over, 6 lbs.; a race, 8 lbs. (Maiden and claiming races not considered). A trophy will be presented to the winning owner.



KARAKORUM SPLENDOR raced with the pace from the outside, dug in outside in the stretch and prevailed after a long, hard drive. AVERY HALL set the pace along the inside, responded when roused, dug in on the rail and just missed. FOUNTAIN'SPRINCESS was outrun early, came wide into the stretch and lacked a rally. MS LITIGATOR was outrun early, raced inside and had no response when roused. DYNAMO HUM raced close up early, put in a three wide run on the second turn and tired in the stretch. STELLAR MAIDEN raced three wide and tired.
