Footnotes

DAYATTHESPA away in good order, was the innermost of a threesome engaged in a battle for the front for most of the way down the backstretch, was taken hold and eased back for a respite, slipped off the rail early on the turn, kept within range throughout the run around the bend, bid three wide turning for home,already under encouragement from just past the five-sixteenths pole, surged by the front runners to take over in upper stretch, primarily under a vigorous hand ride, held a comfortable advantage with a sixteenth off go before successfully geared down. QUIET ENDING in mid-pack behind rivals early down the backstretch, was maneuvered over towards the three path nearing the turn, gave chase from well off the inside, came home willingly to secure second. STOCK FUND was urged along while pursuing the front runners from off the rail, split rivals without hesitation in the vicinity of the five-sixteenths pole to continue the bid, commenced the stretch drive placed in the four path at the top of the lane and displayed a good kick down the center of the strip to garner the show. LADYWELL COURT broke a few lengths off the pack after brushing the left side of the starting gate, chugged along down the backstretch before settling into stride in time for the run around the bend, closed the gap readily taking the inside route, was taken off the rail nearing the quarter pole, spun two wide into the lane, roused, gradually moved outward a couple of additional paths under left handed stick work in mid stretch, finished well belatedly for the last major award. SATIN SHEEKS contested the pace from the outside until upper stretch before backing away. READ THE RESEARCH driven four wide into the stretch, lacked the needed response. BARREL OF JOY argued for the lead from between rivals until the nearing the end of the backstretch, was taken over to the inside once the eventual winner was eased back and went one on one with SATIN SHEEKS thereafter on the turn, failed to keep pace

with the top one after turning for home, and tired. LISINI off a beat slowly, was hustled along to rejoin the pack, shied outward from another opponent twice as she proceeded down the backstretch, was encouraged while racing along the outside on the turn, had no stretch offering to render. FALSE ALIBI off the inside, folded. MIGHTY REWARD faded off a ground-saving journey.
