Footnotes

JONRAH brushed with a rival just after the start, raced off the rail on the first turn, was reserved towards the rear, went three wide early on the far turn, angled five wide nearing the five-sixteenths pole, advanced on the outside while under urging, made a bid while under a right-handed whip after turning into the stretch, switched to a left-handed whip while narrowly in front at the furlong marker, led into the final sixteenth and gamely prevailed under strong urging. SNEAKY KITTEN was taken back then dropped in, raced off the rail on the first turn, was reserved at the back, went four then five wide on the far turn, came six wide into the stretch, was put to a drive on the outside, gained ground into the final furlong and finished with good energy to get the place. MIA POPPY was away awkwardly but broke in front, chose the three path on the first turn, disputed the pace on the outside, vied in the three path on the far turn, floated four wide while in front into the stretch, came under a drive while alongside the winner, battled into the final sixteenth and was outfinished while just able to get the show. FRONT raced off the rail on the first turn, settled while under some light urging on the backstretch, went three to four wide on the

far turn, was passed by the winner on the outside late on that bend, shifted five wide into the stretch while asked, moved in while gaining near the furlong marker and finished with good courage to just miss the show. STATUS OF FORCES was last away, angled in at the rear of the field, raced towards the rail on the first turn, lingered towards the back, waited in last while behind traffic on the far turn, moved to four wide late on that bend, angled out under a left-handed whip in upper stretch and finished with late energy but reached his best stride belatedly. ALARMED NDANGEROUS saved ground on the first turn, was rated off the pace, raced off the rail on the far turn, was crowded in traffic outside the quarter-pole, shifted four wide while put to urging into the stretch, chased under a drive, angled in near the furlong marker and also finished willingly. FOURSEVENTEEN bobbed at the start, settled on the inside, moved closer near the half-mile pole, waited behind traffic while inside on the far turn, came off the rail while put to a drive at the top of the stretch, dropped back to the inside shortly thereafter, steadied when TAPITDAR drifted in front of him near the three-sixteenths pole, steadied again when blocked at the furlong marker, moved to the outside and lacked the needed response. LAWYER JIM was brushed just after the start, went three wide on the first turn, settled off the pace, moved closer near the half-mile pole, raced four wide on the far turn, came under a drive turning into the stretch, chased the vanguard, angled in near the furlong marker and tired. TAPITDAR was well placed just off the pace while off the inside, went two to three wide while amongst horses on the far turn, came under a drive turning into the stretch, drifted to the rail around the three-sixteenths pole and weakened. SWAG DADDY disputed the pace on the inside, dropped out under the whip near the quarter-pole and gave way. (Rail at 9 Feet)
