EVEN THE SCORE was taken in hand while in a bit tight along the rail going into the first turn, was unhurried while trailing along he backstretch, rapidly closed the gap while three wide on the tun, made a run outside CRAFTY SHAW to challenge in midstretch, battled into deep stretch and prevailed in the final strides. CRAFTY SHAW moved up to take the lead on the first turn, extended his margin along he backstretch, maintained a clear lead in upper stretch, fought gamely into deep stretch and yielded grudgingly. FREE OF LOVE was outrun for a half, gained between horses on the turn then lacked a strong closing bid. REQUEST FOR PAROLE moved up along the rail after going a half, was shuffled back along the rail on the far turn and failed to threaten thereafter. JUDGE'S CASE raced in good position between horses for six furlongs and lacked the needed response when called upon. AMERICAN STYLE broke inward at the start, chased the pacesetter from outside to the far turn and gave way. NORTH EAST BOUND faltered after going five furlongs.
