STAKES De La Rose S. - Thoroughbred

(UP TO \$12,350 NYSBFOA) INNER TURF FOR FILLIES AND MARES FOUR YEARS OLD AND UPWARD WHICH HAVE NOT WON \$50,000 ON THE TURF IN 2003-04. A supplemental nomination fee of \$200 may be made at time of entry. \$100 to enter and \$100 to start, with \$65,000 added. The added money and all fees to be divided 60% to the owner of the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth and 2% divided equally among remaining finishers. 123 lbs. Non-winners of \$45,000 on the turf in 2004 allowed 3 lbs.; \$45,000 in 2003-04; or four races, 5 lbs.; three races, 7 lbs. (Maiden, claiming, starter and restricted allowance races not considered). Highweights preferred. Ties broken by total turf earnings. The New York Racing Association reserves the right to transfer this race to the Main Track. A presentation will be made to the winning owner. Closed Thursday, August 5, 2004 with 39 nominations.



Footnotes

FAST COOKIE raced with the pace from the outside while well in hand, moved to the pacesetter approaching the stretch, dug in resolutely when set down for the drive and prevailed under steady pressure. SNOWDROPS (GB) was rated along while between rivals, was blocked in traffic in upper stretch, altered course to the outside and finished fast once clear. SUPER BRAND (SAF) raced in hand outside, rallied four wide on the second turn and dug in gamely while between rivals in the stretch. NANNYCAM raced close up inside while in hand, saved ground, responded when roused and finished gamely inside. HIGH COURT (BRZ) was outrun early while between rivals, came wide into the stretch and finished gamely. BIJOU was outrun early, raced inside and offered a mild rally inside. GUANA (FR) showed good speed while three wide, chased the pace and faded in the final furlong. MYMICH was rated along early, raced wide throughout and lacked a rally. FEISTY BULL quickly showed in front, set the pace along the inside and tired in the final furlong. REASON TO TALK dropped back early, raced inside and had no response when roused.
