INNER TURF FOR FILLIES AND MARES FOUR YEARS OLD AND UPWARD WHICH HAVE NOT WON \$50,000 ON THE TURF IN 2004-05. No nomination fee. A supplemental nomination fee of \$200 may be made at time of entry. \$100 to enter and \$100 to start, with \$65,000 added. The added money and all fees to be divided 60% to the owner of the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth and 2% divided equally among remaining finishers. 124 lbs. TURF: Non-winners of \$45,000 on the turf in 2005 allowed 3 lbs.; \$45,000 on the turf in 2004; or four races, 5 lbs.; three races, 7 lbs. DIRT: Non-winners of \$60,000 on the dirt in 2004-05 allowed 4 lbs.; \$45,000 on the dirt in 2004-05, 6 lbs.; four races, 8 lbs. (Maiden, claiming, starter and restricted allowance races not considered for turf and dirt). Condition eligibility preferred. Ties broken by total turf earnings. The New York Racing Association reserves the right to transfer this race to the Main Track. A presentation will be made to the winning owner. Closed Thursday, August 4, 2005 with 44 Nominations.

PATH OF THUNDER quickly showed in front, made the pace along the inside, dug in when roused and was driving under the wire. WITH PATIENCE prompted the pace from the outside and stayed on stubbornly to the finish. SHARP NEEDLE (GB) was rated along early, rallied inside into the stretch and finished gamely. SUMMER RAINBOW raced close up inside while in hand, saved ground and lacked a rally. BROAD HOPES was outrun early, raced inside and finished well inside. FAST COOKIE raced with the pace while three wide and tired in the stretch. BRIGHT ABUNDANCE was rated along between rivals and had no rally. BRUNILDA (ARG) stumbled after the start and had no rally. CUPID'S ARROW was outrun early and had no response when roused. HIGH COURT (BRZ) raced three wide and tired.
