**Footnotes**

FEROCIOUS FIRES hustled away from starting gate, was put under rating tactics, content to stalk the leader from the three path, continued to bide his time during the run around the bend as he gradually advanced toward the front, entered the lane on even terms with COUGAR CAT, began to slowly take control when asked for a response in upper stretch, then edged clear during the final furlong under good handling. RALLYING CRY within striking distance while racing along the outside, found his best stride leaving the eighth pole to take the place. HOLLYWOOD LEFT under a good hold while saving ground, rallied willingly along the rail to loom midstretch, failed to sustain his bid. COUGAR CAT set the pace off the inside, weakened during the final furlong. FRISCO STAR was always outrun.
