Footnotes

SMOKEY GLACKEN hit the gate at the start, was hustled to the front, set the pace, dug in in the stretch, came inward in deep stretch, brushing with SCHEDULE, and prevailed after a stiff drive. SCHEDULE (GB) pressed the pace along the inside, dug in gamely on the rail, was in tight quarters on the rail in deep stretch, brushed with the winner, was steadied and dug in to the wire. PLEASANT HOME was outrun early, rallied three wide on the turn and finished well. FORTY MOVES chased the pace from the outside and lacked a rally. GRAB BAG was steadied after the start and had no rally. LILAH tired after a half mile. There was a Stewards' Inquiry focusing on the incident involving the top two finishers in the stretch before the result was declared official. In addition, a claim of foul lodged by the rider of the second place finisher against the winner alleging interference in the stretch was disallowed.
