LISTON rushed up along the rail, set the pace along the inside into upper stretch and edged clear under a vigorous hand ride. CHIEF COUNSEL saved ground for a half, angled out in midstretch and was gradually gaining on the winner at the finish. BROTHER BIRD was reserved early, lodged a three wide move to reach contention at the quarter pole and flattened out. WORLD RECORD broke inward at the start, was outrun for a half along the inside, swung six wide at the quarter pole and lacked a strong closing response. WEST HAMPTON moved in on the far turn, swung four wide entering the stretch and lacked a further response. CALLIDE VALLEY pressed three wide for a half and gave way. RUN TO GRAND AVE. failed to threaten after breaking slowly.
