BAYMONT was unhurried early after breaking a bit slowly, trailed for five furlongs, stayed to the inside while launching her bid at the top of the stretch, closed strongly along the rail in midstretch, altered course between horses while gaining in deep stretch and edged SQUARE DANCING in the final strides. SQUARE DANCING steadied along the inside on the first turn, was unhurried while saving ground along the backstretch, raced in traffic leaving the far turn, slipped through along the rail while moving into contention at the top of the stretch, battled along the inside into deep stretch, but couldn't withstand the winner's late charge. MOOREBELLA raced closest to the pacesetter in the two path to the turn, closed the gap nearing the quarter pole, gained a slim lead in upper stretch, fought gamely into deep stretch and yielded grudgingly. PENNY DREAM steadied between horses on the first turn, settled in good position for a half, swung out while gaining on the turn and finished willingly from outside. LADY GWEN steadied in tight between horses on the first turn, was unhurried to the turn and lacked the needed response when called upon. TRANSPARENCY failed to mount a serious rally while four wide throughout. HELEN'S LEGACY sprinted clear in the early stages, set the pace into upper stretch and gave way. DEED raced in close contention between horses for six furlongs and steadily tired thereafter.
