Footnotes

FANTASTIC EYES was urged along near the middle of the field, raced off the rail on the turn, shifted out in upper stretch, rallied into the final furlong, closed well to get the lead outside the sixteenth-pole, drifted out under a right-handed whip leaving that pole and moved clear under steady handling. IDEAL PLACE broke a bit slow, was urged along while off the pace, raced inside early on the turn, angled three wide in the vicinity of the five-sixteenths pole, moved out in upper stretch, gained ground on the outside into the final furlong, hesitated when FANTASTIC EYES came out near the sixteenth-pole and finished willingly while second best. DISSENSION was well placed just off the pace, raced inside on the turn, drafted behind the leaders coming to the quarter-pole, came off the rail and was asked at the top of the stretch, waited while blocked from the three-sixteenths pole to the eighth-pole, found room one off the inside shortly thereafter and just got up for the show. TAPIT TO ME settled just off the pace while the rider had no whip, raced off the rail early on the turn while getting a little extra left-rein pressure, shifted four wide nearing the quarter-pole, made an outside bid in upper stretch, led into the final furlong but was outkicked then lost the show. HEADING TO TOGA showed good speed, lugged out a bit while chasing the pace on the outside, went three wide

while getting heavy left-rein pressure on the turn, made a bid near the five-sixteenths pole, battled on even terms into the final furlong and weakened then broke down after the wire and was humanely euthanized. COLORME KITTEN chased the pace on the outside, went four then five wide on the turn, pursued the vanguard into the final furlong and tired. MISS SWEET AFLEET settled at the rear of the field, raced inside early on the turn, came off the rail before the five-sixteenths, shifted three wide into the stretch, moved out near the three-sixteenths pole and failed to threaten. GUYANA STAR was taken in hand early, lagged well back in the field, raced inside on the turn and was no factor. MY DAUGHTER'S SONG was hustled from the start, set the pace through sensible fractions, vied inside on the turn, was asked nearing the quarter-pole, came under a drive in upper stretch, battled into the final furlong and gave way. PROUD SIREN leaned out at the start, lacked speed while urged along, went two then three wide on the turn, came five wide into the stretch and never reached contention. Following the race, the rider of IDEAL PLACE claimed foul against the winner for alleged interference near the sixteenth-pole. After the stewards' review, there was no change made to the order of finish. (Rail at 27 Feet)
