The purse to be divided 60% to the winner, 20% to second, 10% to third, 5% to fourth, 3% to fifth and 2% divided equally among the remaining finishers. 124 lbs. Non-winners of \$35,000 twice in 2009 allowed 3 lbs. \$35,000 at a mile or over in 2009; or three races, 5 lbs.; \$30,000; or two races at a mile or over, 7 lbs.; arace at a mile or over, 9 lbs. (Maiden, claiming and starter races not considered). A trophy will be presented to the winning owner. Should any horse sweep all three races in the series (The Mike Lee at Belmont Park, The New York Derby at Finger Lakes R Race Track and the Albany at Saratoga) a bonus of \$250,00 will be paid to the winning owner of record for the Albany. **Footnotes**

FIDDLERS AFLEET took the lead soon after the start, set a rapid pace inside for six furlongs, dug in when challenged in midstretch and prevailed under strong urging. SLEVIN was well placed for a half, swung three wide while closing the gap on the turn, made a strong run to challenge in midstretch and was outfinished by the winner while clearly second best. SUMMER SHARE was outrun for six furlongs, swung four wide on the turn and lacked a strong closing bid. LEGAL CONSENT raced up close between horses, lodged a mild bid on the turn and gave way in upper stretch. TALL POPPI saved ground while well back, angled out on the turn and lacked a rally. POCKET COWBOYS pressed a quick pace outside the winner and gave way on the far turn.
