GO UNBRIDLED went three wide early on the first turn then dropped to the inside, settled while coaxed along, moved up inside the five-eighths pole then shifted out, kept DREAMING OF CARA in behind the leaders late on the backstretch, went three to four wide on the far turn, was given his cue outside the five-sixteenths, rallied under a right-handed whip in upper stretch, took the lead near the furlong marker and drew clear under strong handling. LADY ON THE RUN raced off the rail on the first turn, settled on the outside, moved up with a half-mile to run, was urged along while four to five wide on the far turn, chased under a drive in upper stretch and narrowly earned the place while no match for the winner. MISCHIEF MAKER bumped lightly twice with a rival at the start, disputed the pace on the outside, vied two to three wide on the far turn, was asked near the five-sixteenths, put SHESABRONXBOMBER away at the quarter-pole, was quickly challenged by the winner, lost the lead to that rival at the furlong marker and proved no match for the winner then lost the place. DREAMING OF CARA saved ground on the first turn while getting a little extra left-rein pressure, moved up with five furlongs to run, was kept in the pocket behind the leading duo late on the backstretch, drafted behind opponents while off the rail on the far turn, came out under a drive in upper stretch, was ridden along while behind horses into the final furlong and lacked the needed kick and just missed the minor awards. TAHOE TIGRESS raced off the rail on the first turn, settled towards the rear, moved closer with a half-mile to run, was asked while off the rail at the three-eighths, moved to three wide shortly thereafter, turned into the stretch under a drive and lacked the needed response. SHESABRONXBOMBER bumped lightly twice with an opponent at the start, disputed the pace on the inside of MISCHIEF MAKER, dropped back leaving the far turn and gave way. GUYANA PRINCESS dropped well behind while racing on the inside, came off the rail near the quarter-pole, drifted out in upper stretch and was no factor.
